Vietnam Era Veterans Honored

In recognition of a chapter in our Nation's history that must never be forgotten, let us renew our sacred commitment to those who answered our country's call in Vietnam and those who awaited their safe return. The Federal Government has partnered with local governments, private organizations, and communities across America to participate in the Commemoration of the 50th Anniversary of the Vietnam War-a 13-year program to honor and give thanks to a generation of proud Americans who saw our country through one of the most challenging missions we have ever faced. While no words will ever be fully worthy of their service, nor any honor truly befitting their sacrifice, let us remember that it is never too late to pay tribute to the men and women who answered the call of duty with courage and valor. Let us renew our commitment to the fullest possible accounting for those who have not returned.

On 27 January at the Baltimore Detachment meeting, John Henkel, DoD Veterans Advocacy Representative in a Vietnam Era Veteran Commemorative Ceremony, acknowledged 20 veterans who served in that era. Veterans who were unable to participate were acknowledged also.



Maryland Veterans Legislative Day

9 February: Representatives from Maryland VSO's met in Annapolis at the Miller Senate Office Building for the first Annual Maryland Veterans Day. Hosted by Delegate C. T. Wilson, Chairman Veterans Caucus.

MDVA speakers presented topics on Veterans Workforce Development and Center for Veterans Education.

Following the presentation, we navigated to the State Central Building, sitting in General Assembly sessions while being introduced as testimonial VSO representatives for the many veteran bills proposed.

After returning to the senate office building for lunch, we were addressed by MDVA Secretary George Owings III. A discussion followed on the activity of the veteran bills proposed. Two of the bills discussed are stated here. Stuart Blair, PDC, Commissioner MVC represented the Marine Corps League.

Military Retiree Tax Relief

Governor Hogan's Proposed Legislation Would Exempt Military Retirees From State Income Tax On Their Military Retirement Income. "The extent included in federal adjusted gross income, the amounts under this section are subtracted from the federal adjusted gross income of a resident to determine Maryland adjusted gross income... All military retirement income received by an individual during a taxable year beginning after December 31, 2019." ("Senate Bill 321," Maryland General Assembly, 1/20/17)

Senate Bill 579 POW / MIA Flag

This bill requires the Secretary of General Services and Secretary of Transportation to cause the POW/MIA flag to be flown on the grounds of all state Buildings under their control whenever the U.S. flag is flown.

Our hearts are filled with gratitude for the men and women who serve our country, and for the sacrifices their families make so that we can all enjoy the blessing of freedom. We praise you for calling them to help protect us, and for giving them the courage and ability to do their jobs well. Guide their choices and their actions, Lord. Help them to see you working in their daily lives, whether in the field, at home, or abroad. Surround them with your mighty angels; protect them in your mercy; cover them with your grace. Guard their hearts while they are far from loved ones, and bless them with moments to cherish when they are together. Hold these families close, Lord. May they look to You for the strength and peace that only You can give. Amen The Department of Veterans Affairs (VA) is committed to providing Veterans with quality, safe and compassionate health care in a timely manner. To that end, we are amending provider regulations to permit full practice authority to three roles of VA advanced practice registered nurses (APRN) to practice to the full extent of their education, training, and certification, regardless of State restrictions that limit such full practice authority, except for applicable State restrictions on the authority to prescribe and administer controlled substances, when such APRNs are acting within the scope of their VA employment.

"Advanced practice registered nurses are valuable members of VA's health care system," said VA Under Secretary for Health Dr. David J. Shulkin. "Amending this regulation increases our capacity to provide timely, efficient, effective and safe primary care, aids VA in making the most efficient use of APRN staff capabilities, and provides a degree of much needed experience to alleviate the current access challenges are affecting VA."

The proposed rule stated that VA would grant full practice authority to the four APRN roles. Though VA does have some localized issues, we do not have immediate and broad access challenges in the area of anesthesia care across the full VA health care system that require full practice authority for all Certified Registered Nurse Anesthetists (CRNAs). Therefore, VA will not finalize the provision including CRNAs in the final rule as one of the APRN roles that may be granted full practice authority at this time. However, VA CRNAs that are granted full practice authority by their state license will continue to practice in VA in accordance with their state license and subject to credentialing and privileging by their VA medical facility's medical executive committee. VA will not restrict or eliminate these CRNAs' full practice authority.

VA will request comment on the question of whether there are current anesthesia care access issues for particular states or VA facilities and whether permitting CRNAs to practice to the full extent of their advanced authority would resolve these issues.
